THE PGTA IS WHERE THE INDIGENOUS PEOPLES EXPRESS THEIR ASPIRATIONS AND DRAW UP THEIR PATHWAYS AND STRATEGIES TO CARE FOR THE FOREST, THE WATERS, THE FLORA AND FAUNA, AND THEIR COMMUNITIES OVER THE LONG TERM, BASED ON THEIR WORLDVIEW.

- IN GUYANA, ANCESTRAL MAPPING HAS BEEN CARRIED OUT IN AND WITH THE FULL PARTNERSHIP OF FOUR MACUSHI INDIGENOUS COMMUNITIES, RESULTING IN TERRITORIAL AND VILLAGE MAPS WITH MORE THAN A THOUSAND LANDSCAPE AND DEMOGRAPHIC DATA POINTS. AMONG MULTIPLE OBJECTIVES, THE ENDEAVOR SEEKS TO EMPOWER COMMUNITY GOVERNANCE AND BOLSTER PROTECTION OF BIODIVERSITY.
